INTRODUCTION

Many questionnaires have a question "Please write the main business activity of the organisation where you work". The answer is commonly asked as an open text field, challenging the survey holder to code the response into an industry classification. Alternatively, in a web survey respondents can self-identify their industry from a list of industries. In case of a long list, typically a search tree is used, derived from a database of industry names.

Since 2001 WageIndicator uses a search tree for the question about industry in its **Salary Survey** and its **Salary Check**. Since 2014 WageIndicator uses this search tree also for industry identification in its **Collective Agreements Database** (CBAs). This paper details the WageIndicator industry database in relation to the coding of one or multiple industries associated with these three applications. For further details of the industry coding of CBAs see *APPENDIX I. NACE codes for the coding of sectors*, in Borbely et al (2023). The names of the industries in the database have been translated in some 60 languages to suit worldwide measurement in the WageIndicator surveys and tools. This Manual is an update of an earlier version (Tijdens, 2016).

NACE AND ISIC INDUSTRY CLASSIFICATIONS

The United Nations maintains the International Standard Industrial Classification of All Economic Activities (ISIC). Its latest version is **Revision 4** - published in 2008. In the European Community the NACE Statistical Classification of Economic Activities is used, commonly referred to as NACE.2 In 2008, NACE was thoroughly revised, changing versions from NACE1.2 into **NACE Rev 2** (EUROSTAT 2008). NACE is derived from ISIC, but it is more detailed than ISIC. The United Nations provide a correspondence table between ISIC Rev.4 and NACE Rev.2.4. In 2025 Eurostat will implement **NACE Rev 2.1**. At the time of writing WageIndicator has not yet implemented this version.

The NACE industry classification is a hierarchical classification with four levels (called digits), see table below.

WAGEINDICATOR INDUSTRY DATABASE

The WageIndicator industry database, here referred to as the *Industry_API*, facilitates the measurement by means of a search tree for 321 industry entries all coded at NACE-rev2 3-digit or 4-digit level. The search tree is a hierarchical tree, consisting of 2 tiers. The first tier largely overlaps with the 21 NACE-rev2 1-digit categories, but has slightly been adapted, because NACE is not designed to suit the requirements for a search tree in surveys. In two ways the first tier in the WageIndicator search tree was adapted. First, the search tree had to facilitate an comparable number of entries across the 3 - 4-digit entries at the second tier. For example, the industry 'G Wholesale and retail trade; repair of motor vehicles and motorcycles' has many entries at 3 or 4 digit NACE level and therefore we decided to break G down in three entries, as the table on the next page shows. Secondly, the search tree was adapted with an eye on the employment size of the industry. For example, the industry 'T Activities of households as employers' has typically few people employed and was therefore squeezed into the WageIndicator industry 'Security, cleaning, homework'. The table on the next page shows the first tier of the search tree and its correspondence to the NACE 1-digit codes.

The first tier in the WageIndicator search tree consist of 20 entries, followed by a second tier with in total 320 entries. At this second tier, WageIndicator tried to include all 4-digit NACE codes, but some only could be mapped to 3-digit NACE codes. The reason is that some 4-digit codes are too detailed to reflect an existing industry, and may even no longer exist. This is particularly so in manufacturing industry. In these cases, the second tier corresponds to the relevant 3-digit NACE codes. The first column in the 4th table in the Appendix shows at which NACE digit the industry variable in WageIndicator is measured.

Some WageIndicator projects target specific industries, such as the Ready-Made-Garment factories or the Flower Farms. In the surveys for these projects the industry list should not consist of the 321 entries, but only include the relevant industries. The technology of the *Industry_API* allows to do so. WageIndicator also conducts projects for which industry needs to be measured at greater detail than the current 3-digit NACE categories allow, e.g. the growing of rice (NACE 4 digit code 112) is classified in the 3-digit aggregate category of growing of crops, market gardening, horticulture (code 110). Such categories have been added to *Industry_API*. The *Industry_API* regulates that for these projects only the relevant industries are shown in the web survey at stake. Finally, the industry coding of CBAs is sometimes not possible for 3- or 4-digit NACE, but only at 2-digit or even 1-digit. For example an Agreement for the entire Retail industry is coded at 1-digit level. In these cases the values for the NACE 2-digit (variable NACE2002) and for the NACE 3- or 4 digit (variable NACE2004) are coded 9999.

The newest version is NACE revision 2 update 1 (NACE Rev. 2.1), which is to be used for European statistics from 2025 onwards. This was adopted by the European Commission in October 2022.

THE WAGEINDICATOR INDUSTRY API

The *Industry_API* is a structured spreadsheet and the Salary Survey, Salary Check, and CBA database applications all use this API. The API spreadsheet has six tabs, which are explained in the table below.

TAB IN API SPREADSHEET	EXPLANATION
CODESET	This tab includes the list of codes and their labels of all entries on the 1st and the 2nd tier of the search tree and the translations in the labels for currently approximately 200 locales. Locales indicate the language and the country. Note that the codes at the 1st tier of the search tree have a negative value and those of the 2nd tier a positive value.
STRUCTURE	This tab indicates the structure of the search tree, nesting the 1st tier codes into the 2nd tier. By using a country + project code, it also indicates if for certain projects only a limited list of industries is relevant, e.g. for projects concentrated in the Textile, Ready-Made-Garment and Leather goods and Footwear industries.
MAPPING	This tab includes all codes from the CODESET tab 1, and their mapping into the NACE and ISIC codes, as well as their measurement level.
CBA DATABASE MAPPING	This tab shows the reverse mapping, notably from NACE 4-digit to the code of the 1st tier search tree.
LABELSET	This tab includes the labels of all codes used in the MAPPING tab.
MAPPING NACE	This tab reproduces the NACE Rev2 4 digit level structure

QUESTIONS FROM CODERS OF THE CBA DATABASE

NOTE: Users have asked: "what about the factories which make both fabric and clothes? Can I assign two main sectors?". Unfortunately, the API cannot classify two codes for one company or factory. The choice for the classification depends on its largest share of the factory's turnover. In case of the DecentWork projects, in the webpages the two lines of business can be elaborated in the cell "detailed line of business".

NOTE: Users have asked: "Shoes accessories such as shoestring or garment accessories such as buttons, zipper, etc, how should they be classified?" These are classified as Garment and accessories (code 1400).

NOTE: Users have asked: "Bags, gloves made out of leather, or soles, etc how should they be classified?" These are classified as Footwear, leather, and rubber (code 1500).

NOTE: Users have asked: "Towels, etc how should they be classified?" These are classified as Textile (code 1300).

NOTE: Users have asked: "Laundry services, toys (plush dolls) etc how should they be classified?" These are classified as Other (code 99999).
